OBJECTIVES AND INVESTMENT POLICY

The Sub-Fund, expressed in Euro, aims at providing positive returns defined as a mix of income and capital growth over a period of 5 years starting from 1st June 2018 (the Principal Investment Period). The Sub-Fund is suitable for investors who search medium term investments and the investor must be able to accept a certain volatility and the possibility of losing part of the invested amount. The Sub-Fund has been designed for investors who will invest in the Sub-Fund during the Initial Subscription Period and will hold their investment until the end of the Principal Investment Period. The return forecasts may differ if the investor does not intend to hold the investment until the end of the Principal Investment Period.

The Sub-Fund seeks to achieve its investment objective by investing in a flexible allocation to debt securities from all issuer types globally, (including emerging market debt) and global equities. The Sub-Fund selects eligible securities from the world-wide range of fixed-interest and floating rate securities including corporate bonds, non-investment grade, contingent convertibles ("CoCos"), government, and supranational bonds. The Sub-Fund may also invest in bonds issued by securitization vehicles or equivalent such as Mortgage Backed Securities (MBS), Asset Backed Securities (ABS) and Collateralised Loan Obligations (CLO). The Sub-Fund may invest:

- up to 70% of its net assets in non-investment grade debt securities (including non-investment grade debt issued by emerging markets issuers);
- up to 40% of its net assets in global equities (including emerging markets equities);

- up to 30% of its net assets in government, corporate bonds (investment grade and non-investment grade) and equities issued by entities located in emerging markets;
- up to 20% of its net assets in CoCos;
- up to 10% of its net assets, in assets issued by securitization vehicles such as ABS, MBS, CLOs.

Exchange rate exposure will be possible up to 30% of the Sub-Fund's net assets. In an adverse market environment, or, on approaching the end of the Principal Investment Period, the Sub-Fund is allowed to be exposed up to 100% of its assets to money market instruments and cash. During the Initial Subscription Period (from 9th April 2018 to 31st May 2018) the Sub-Fund will hold 100% of its net assets in cash, denominated in Euro. The Sub-Fund may use financial derivative instruments, listed or OTC, for the purpose of risk hedging, investment and efficient portfolio management. The Sub-Fund will not enter into Total Return Swaps (TRS). The Sub-Fund will not purchase distressed securities nor default securities.

Once the terms of the Principal Investment Period have expired, there will be progressive investment seeking to consolidate the performance achieved. The Sub-Fund has no benchmark.

The Sub-Fund has two Share-Classes: Class R is a capitalization Share-Class. With reference to the Share-Class S, the net incomes of the Sub-Fund will be distributed in accordance with the Prospectus of the Fund. You may request to redeem the shares held at any moment, by sending a request on any business day.

- **Credit risk:** The Sub-Fund invests in securities whose credit rating may get worse, increasing the risk that the issuer is unable to fulfil its commitments with a negative impact on the securities' price.
- **Liquidity risk:** The Sub-Fund invests in markets that can be characterized by a reduced possibility to exchange securities without a negative impact on prices.
- **Developing market risk:** The Sub-Fund is exposed to securities highly sensitive to political and economic instability of developing countries; price changes may be higher than those in the markets of developed countries.
- **Counterparty risk:** The Sub-Fund invests into instruments, such as derivatives, by entering into contracts with financial counterparties, exposing itself to the risk that said intermediaries may generate financial damage to the fund itself by not fulfilling their obligations in the future.
- **Derivative risk:** In order to achieve its objectives, the Sub-Fund may use derivative instruments whose value may be subject to price fluctuations, positive or negative, much larger than those of the securities in the same Sub-Fund.
- **Regulatory risk:** Risk of failure to comply with applicable regulatory requirements (in particular in respect of securitization, leverage) may impact negatively the Sub-Fund.

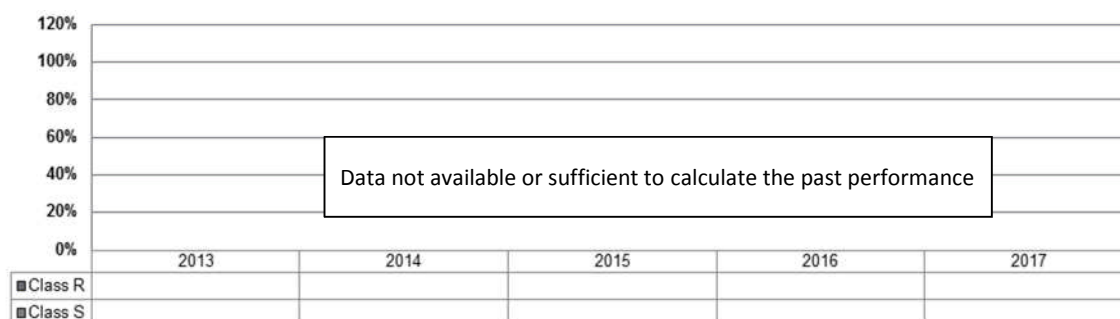

It excludes performance fees and portfolio transaction costs, except in the case of an entry/exit fee paid by the Sub-Fund when buying or selling units in another fund.
